**School fee structure Hollandse School Limited (HSL) school year 2016 – 2017**

**School terms**

The school year (15 August 2016 – 23 June 2017) consists of three terms:

- Term 1: Aug 15, 2016 – Dec 16, 2016
- Term 2: Jan 9, 2017 – Mar 31, 2017
- Term 3: Apr 17, 2017 – Jun 23, 2017

**PRIMARY SCHOOL Group 1 – 8 (4 – 12 years old children)**

**Registration fee**

The registration fee consists of two components (reference is made to the HSL admission policy):

- S\$ 500 (excl. 7% GST) per child (Non-refundable) upon application.
- S\$ 2,500 (excl. 7% GST) per child (Non-refundable) upon confirmation of being admitted to the school.

The relevant amount will be invoiced after HSL has confirmed receipt of all the required enrolment forms and is non-refundable.

**School fees**

For the school year 2016 – 2017, the school fee has been set at S\$19,516 excluding 7% GST (S\$20,882.12 including 7% GST).

The fee is payable in three termly instalments, with the instalment being proportional to the length of each term:

- Term 1: SGD 8,604 (excluding 7% GST) – 82 days
- Term 2: SGD 5,876 (excluding 7% GST) – 56 days
- Term 3: SGD 5,036 (excluding 7% GST) – 48 days

The invoices for existing students will be sent out by

- The 1<sup>st</sup> of June, the 1<sup>st</sup> of October and the 1<sup>st</sup> of February for the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> terms respectively.

There will be a 30 day payment term stated in each invoice.

**Start after school term has commenced**

If a child joins the school after the commencement date of a term, the fees will be calculated pro rata per actual school day until the end of the term at S\$ 105 (excl. 7% GST) per day.

## **Withdrawal**

The latest dates for notice of withdrawal from the school for the school year 2016 – 2017 are set as:

- Friday 9 September 2016 for the second term,
- Friday 20 January 2017 for the third term, and
- Monday 17 April 2017 for the first term of the school year 2017 – 2018.

If notice of withdrawal is not given before or on the stipulated date for notice of withdrawal, the HSL will claim the ensuing school term fee.

The terms of withdrawal also apply if enrolment is withdrawn before the student joins the HSL. The HSL is not obligated to refund any School fees paid. The decision to refund will be at the sole discretion of the Board of Governors.

## **Withdrawal during term**

Children can also be withdrawn during the term, as long as the notice period stated above is adhered to.

For example, if you want to withdraw your child during Term 2, you will need to notify the school before 9 September 2016 otherwise the full term will be charged.

For a withdrawal during the following term, the fees will be calculated pro rata per actual school day from the start of the term to the withdrawal date at S\$105 (excl. 7% GST) per day.

## **PRE-SCHOOL JIP EN JANNEKE (2 – 4 years old children)**

### **Registration fee**

- S\$ 500 (excl. 7% GST) per child (Non-refundable) upon application.
- The amount of S\$2,500 (excl. 7% GST) will be invoiced once the child enters primary education of HSL and is non-refundable.

### **School fees**

- School fee per day 8:30 am – 12noon: S\$55 (excl. 7% GST).
- Extended schooldays from 12noon – 2:30pm will be charged at S\$39.50 (excl. 7% GST) per day.

Holidays are not charged. The invoices for the number of scheduled days will be sent out at the beginning of each term.

There will be a 30 day payment term stated in each invoice.

## **Withdrawal**

The term of notice for withdrawal from J&J is four weeks. In case of withdrawal before the starting date, the first four weeks will be invoiced.
